**ORDER**

In order to improve overall financial management system, Single Bank Account System of ICICI Bank is to be implemented in NUHM/HSS (Urban) at Municipal Corporations and Municipalities under purview of NUHM w.e.f 1<sup>st</sup> August 2023. The implementation of the system shall ensure better fund management and budgetary control. This system will facilitate real time reporting and preempt idle unspent balance at Municipal Corporations and Municipalities under NUHM.

As the system (Digipay) is ready to use and training of concerned personnel is completed, it is hereby ordered that:

1. Expenditure of all activities under NHM including NUHM shall be made by Municipal Corporations and Municipalities under purview of NUHM only through Single Bank Account system of ICICI Bank.
2. Limit based fund release to Municipal Corporations and Municipalities shall only be made through Single Bank Account System of ICICI Bank.
3. Municipal Corporations/Municipalities shall make all transaction of NHM including NUHM through Single Bank Account System of ICICI Bank (NUHM).
4. Under guidance of State FMG, proper books of accounts in accordance with change in system may be maintained.

This Order will take effect from 1<sup>st</sup> August 2023.




