**ORDER**

As per mandate of DoE (Department of Expenditure), Ministry of Finance, Govt. of India, Single Nodal Account (SNA) System has been implemented in NHM, being Central Sponsored Scheme. Under this system, the fund shall only be allotted to all Implementing Agency (IA) in limit mode instead of release of physical fund. Presently, a system developed by the ICICI Bank (named as idigipay) is functional at all tiers of State, Districts & Blocks for making limit based allocation to Implementing Agencies. This system will facilitate real time reporting and preempt idle unspent balance at different tiers.

Now, it has been decided that limit based allocation system shall be also be implemented in all Medical College & Hospitals (For both Principal Side & MSVP Side) and other Health Institutions. A list of units selected for immediate implementation of limit based allocation system is attached with this Order.

**For above purpose, it is required to open ZBSA (Zero Balance Subsidiary Account) and Holding Account for all Medical College & Hospitals (For both Principal Side & MSVP Side) and other Health Institutions under NHM in any nearest branch of ICICI Bank.** These Zero Balance Subsidiary Account & Holding Accounts of Implementing Agencies shall be linked and functioned under existing Single Nodal Account of NHM opened in ICICI Bank, Sector-V Branch, in name of "WB STATE HEALTH & FW SAMITI (NHM MOTHER)", A/c No. 105601001961, IFSC Code: ICICI0001056. These ZBSA and Holding Accounts shall be operated through joint signatories.

As per approval accorded by Finance Department vide U.O. No.: Group T/2021-2022/0982 dated 24/12/2021, Zero Balance Subsidiary Account (Child Account) may be opened for all the IAs in connection with the Centrally Sponsored Scheme, NHM. Further Group-T of Finance Department has communicated in e-file no. HFW-27021/106/2023-NHM SEC-Dept. of H&FW that permission of Group-T is not required for opening Zero Balance Subsidiary Account (ZBSA) at IA level. In terms of letter no. 89(29)-FB dated 13.05.2022 issued by Finance Department, no separate permission is required from Group-T of FD for opening of Holding Account at IA level for payment of tax and statutory deduction.


**You are further requested to submit details of ZBSA and Holding Account along-with name, email id and contact number of your organization to the under signed for registration in PFMS portal in prescribed format.**
